I agree to waive the right to the use of my photos from the competition, and agree that any actions against the Federation must be brought in New York State.

Federation Release, Assumption of Risk, Waiver and Indemnification

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition Evenstride Ltd. to the following:

I AGREE that "the Federation" and "Competition" as used herein includes the License and Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, volunteers and Federation affiliates.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to hold harmless and release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results resulted, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition.

I have read the Federation Rules about protective equipment, including GR801 and if applicable, EV114, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me that I do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information my injury and treatment to the Federation on the official USEF accident/injury report form.

BY SIGNING BELOW, I AGREE to be bound by all applicable Federation rules and all terms and provisions of this entry blank.

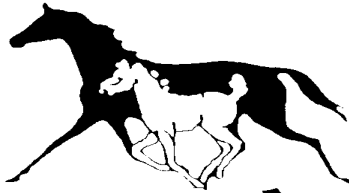

Height of fences 3' for horses, small and medium ponies 2'; large ponies 2'6" spreads not to exceed fence height. If entries warrant, the division may be split at the discretion of show management. Same horse/pony rider combination cannot show in any other rated division except Equitation. Horses may be shown by another rider in any other division or section at the same show. Ponies may not cross enter into the regular pony hunter division. Jogging for soundness at the discretion of the judge.

46. **NEHC JUNIOR HUNT SEAT MEDAL CLASS** Entry Fee: \$30.00
Open to Junior members of the New England Horsemen's Council who have not reached their 18th birthday. All contestants are required to perform over at least eight fences not exceed 3'3". One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF Tests 1 – 19). To fill a class, at least four competitors must complete the course. One win required for the finals.
38. **PESSOA'S USEF HUNTER SEAT MEDAL CLASS*** Entry Fee: \$30.00
Open to Junior members of the USEF who have not yet reached their 18th birthday. Application for membership may be made through the show steward.
39. **ASPCA HORSEMANSHIP CLASS*** Entry Fee: \$30.00
Permanent Championship Trophy of the American Society for the Prevention of Cruelty to Animals, donated by the late Alfred B. Maclay. For Junior riders who have not reached their 18th birthday. No participant will be allowed in a class unless they are a Junior patron and must show their ASPCA number on the entry blank. Annual contributions shall be \$15.00. Application for membership must be made directly to the Horsemanship Department, ASPCA, 441 East 92nd Street, New York, NY 10028.
40. **PLATINUM PERFORMANCE /USEF TALENT SEARCH** Entry Fee: \$35.00
Open to US Citizens who are current members of the USEF who have not reached their 21st birthday and are either Junior or Young Riders and are Amateurs under USEF/FEI rules. The over fences phase of the class shall be over a special course of at least ten fences 3'6" to 3'9" in height with spreads to 5 feet. Wings shall be no wider than 36 inches. The course must include a double and triple combination with at least one spread fence in each. Two other spread fences are required elsewhere on the course and an obstacle with water is recommended. (Will be obligatory in the finals).

14. MHC HUNT SEAT MINI-MEDAL *

Entry Fee: \$30.00

Open to Junior members of the Mass. Horsemen's Council who have not reached their 15th birthday and have not competed in classes in which the entry is required to jump higher than 3'0". All competitors are to compete over a course not exceeding 8 fences and not less than 6, excluding combinations, at a height not to exceed 2'6". One or more individual tests may be requested at the judge's discretion (USEF Tests 1-15). To fill a class at least four competitors must complete the course.

34. T.H.I.S. NATIONAL CHILDREN'S MEDAL *

Entry Fee: \$30.00

Open to Junior members of the USEF or CEF who have never competed in a National Equitation Finals with fences at 3'6" (i.e.: USEF Hunter Seat Medal, ASPCA Maclay, USET or CEF Finals, WIHS Capital Cup). All contestants are required to perform over at least 8 fences 2'9" to 3'0", spreads not to exceed fence height, with at least two changes of direction and a combination. The top four riders, or 20% of the first round competitors, whichever is greater, are required to perform at least two individual tests from USEF Tests 1 – 19. An open numerical scoring system will be used in the first round.

4. MHC ADULT/AMATEUR HUNT SEAT MEDAL *

Entry Fee: \$30.00

Open to adult members of MHC. All contestants are required to perform over at least 8 fences 2'6" to 2'9", with at least one change of direction. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USAEQ Tests 1-17). To fill a class at least four competitors must complete the course.

5. NEHC ADULT/AMATEUR HUNT SEAT MEDAL

Entry Fee: \$30.00

All contestants are required to perform over at least 8 fences not to exceed 3'0". One or more individual tests (USAEQ Tests 1- 17) of the top four competitors may be requested at the judge's discretion. To fill a class at least four competitors must complete the course.

6. ARIAT NATIONAL ADULT MEDAL *

Entry Fee: \$30.00

Open to all members of the USEF or CEF who are eligible to compete in the Amateur Adult Hunter section at this show. All competitors are required to perform over at least 8 fences 2'9" to 3'0", spreads not to exceed fence height. The course may be either a jumper or hunter type course and must include at least two changes of direction a combination. Water obstacles not permitted. The top 4 riders, or 20% of the first round competitors, which ever is greater, are required to perform at least two individual tests from USEF Tests 1-19. An open numerical scoring system will be used in the first round. Class to be judged in accordance with current USEF standards for equitation.

7. GRANITE STATE ADULT MEDAL *

Entry Fee: \$30.00

Open to amateur adults. Fences will not exceed 2'9". Must be a member of the NHHJA to accumulate points for the finals.

37. GRANITE STATE JUNIOR MEDAL *

Entry Fee: \$30.00

Open to junior rider under the age of 18. Fences not to exceed 3'0". Must be a member of the NHHJA to accumulate points for the finals.

RULES & REGULATIONS

- 1. Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) Leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions; 8) Opportunity classes; 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation; 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.**
2. Judges decisions are final.
3. The Committee reserves the right to cancel, combine, or divide the classes when deemed necessary to facilitate the smooth running of the show.
4. Courses will consist of post and rails, walls, pickets and brush.
5. A trophy, championship and reserve ribbons will be awarded in all divisions.
Champion and reserve will be awarded to two of the four horses which have acquired the most points in the over fence classes in their divisions. In addition to these points, only those horses shall receive full points for ribbons won in the under saddle classes. Points to be awarded through the first six places:10-6-4-2-1-1/2.
6. A trophy and/or cash and ribbons will be awarded in all classes unless otherwise stated.
7. Every class offered herein which is covered by the Rules & Specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.
8. No numbers taken for warm-up after 7:30 a.m.
9. Prize money will be deducted from the total entry fees, any prize money in excess of the total entries will be paid in the form of a check within 30 days of the close of the competition.
10. All classes will be judged on performance and soundness unless otherwise stated.
11. Entry Fee: \$20.00 per class unless otherwise stated.
12. Indoor Arena 100 x 200 with a well groomed sand based footing
Outdoor Warm - Up with a stone dust and sand footing
13. Post Entries accepted the day of the show.

RULES & REGULATIONS continued...

14. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
15. Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.
