

28. MHC HUNT SEAT MINI-MEDAL*

Open to junior members of the MHC who have not reached their 15th birthday and have not competed in classes in which entry is required to jump higher than 3'0". All competitors are to compete over a course not exceeding 8 fences and not less than 6, excluding combinations, at a height not to exceed 2'6". One or more individual tests may be requested at the judge's discretion (USEF Tests 1-8). To fill a class at least four competitors must complete the course.

Entry Fee: \$35.00

Open to riders 17 years of age and under, competing on horses or ponies. Riders not to have shown over 2'6" at a recognized show. Contestants to perform over a minimum of six fences with at least one change in direction. Fence heights shall be 2' for small & medium ponies and 2'6" for large ponies & horses. 25% of the contestants, at least 2, may be called back for testing. Testing optional. (USEF Tests 1-8)

Entry Fee: \$35.00

Open to riders 10 years of age and under. Must not have shown over fences or cantered at any horse show. Contestants shall be required to show at a trot over a minimum of four rails (poles) on the ground.

Entry Fee: \$35.00

Open to riders 12 years of age and under, competing on horses or ponies. Riders must have never shown over fences that exceed 18". Riders shall perform a minimum of six fences with at least one change of direction. Fence height 18". 25% of contestants, at least 2, may be called back for testing. Testing optional, verbal recommended. (USEF Tests 1-8)

Entry Fee: \$35.00

Open to riders 13 years of age and older. Riders 13-17 must be in their first three years of showing over fences and have never shown over 2'. Adults not to have shown over 2' in the previous 7 years. Riders shall perform over a minimum of six fences, with at least one change of direction. Fence height 18". 25% of contestants, at least 2, may be cled back for testing. Testing optional, verbal recommended. (USEF Tests 1-8)

Entry Fee: \$35.00

Open to riders 17 years of age and under, competing on horses or ponies. Contestants to perform over a minimum of six fences with at least one change in direction. Fence heights shall be 2'6". 25% of the contestants, at least 2, may be called back for testing. Testing optional.

Entry Fee: \$35.00

Open to all members of MHC who have not reached their 18th birthday. All contestants are required to perform over at least eight fences not exceeded 3'0". One or more individual tests of the top four contestants may be required at the judge's discretion (USEF Tests 1-19). To fill a class, at least four competitors must complete the course.

Entry Fee: \$35.00

Open to Junior members of the NEHC who have not reached their 18th birthday. All contestants are required to perform over at least eight fences not to exceed 3'3" with at least change of direction. One or more individual tests of the top four contestants may be requested at the judge's discretion. (USEF Tests 1—19). To fill a class, at least four competitors must complete the course. One win required for the finals.
